1. **\*\*Order Minimum\*\*:** There's a minimum of 20 units per pattern and a minimum of 100 patterns in each order.

2. **\*\*Payment Terms\*\*:** First payment of 50% is due with order. Remaining balance is due 30 days from the invoice date. Late payments are subject to interest charges at a rate of 10% per month or the maximum allowable by law.

3. **\*\*Order Cancellations\*\*:** Orders canceled after 5 days from the order date or after order confirmation are subject to a cancellation fee of 15% of the order value.

4. **\*\*Shipping & Handling\*\*:** Minimum orders of 100 ship within 10-12 days after 50% payment. Orders over 100 shipped in 10-14 days. Orders shipped via USPS Priority. Distributor pays Flat Rate Priority shipping via United States Postal Service. Living Water Quilter, LLC is not responsible for lost or damaged packages. Distributor may elect to pay insured shipping to cover cost of order.

5. **\*\*Returns & Exchanges\*\*:** Returns are accepted within 3 days of delivery only for damaged or defective products. No Exchanges.

6. **\*\*Stock Levels\*\*:** Distributors are encouraged to maintain an agreed minimum stock level of 20 units to ensure a steady supply to wholesalers.

7. **\*\*Marketing & Promotions\*\*:** Distributors are granted permission to use Living Water Quilter patterns branding and promotional materials for the purpose of selling the patterns. Any other use requires written permission.

8. **\*\*Exclusivity\*\*:** [If applicable] Living Water Quilter patterns agrees not to supply any other distributor within the United States for the duration of the agreement.

9. **\*\*Intellectual Property\*\*:** The designs, patterns, and all related materials remain the intellectual property of Living Water Quilter patterns and may not be reproduced, redistributed, or sold without written permission.

9. **\*\*Governing Law\*\*:** This agreement shall be governed by the laws of the Commonwealth of Virginia, without regard to its conflict of laws principles.

10. **\*\*Dispute Resolution\*\*:** Any disputes arising out of this transaction will first be attempted to be resolved through amicable negotiations. If unsuccessful, both parties agree to submit to binding arbitration in Fredericksburg, Virginia.
